ORDINANCE AMENDING SECTION 3(f) OF BOND
ORDINANCE #7-2024 OF THE TOWNSHIP OF MOUNT
OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY,
FINALLY ADOPTED MARCH 5, 2024, IN ORDER TO
INCLUDE AN ADDITIONAL PROJECT.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds
of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(f) of Bond Ordinance #7-2024 of the Township of Mount
Olive, in the County of Morris, New Jersey (the "Township"), finally adopted March 5,
2024, is hereby amended to include flooring replacement at the Senior Center and to read
as follows:

<u>"Purpose</u>	<u>Appropriation & Estimated Cost</u>	<u>Estimated Maximum Amount of Bonds & Notes</u>	<u>Period of Usefulness</u>
f) <u>Division of Senior Services:</u> Acquisition of a Braunability Voyager van and chair and flooring replacement at the Senior Center, including all related costs and expenditures incidental thereto and further including all work and materials necessary therefor and incidental thereto.	\$129,895	\$123,400	5 years"

Section Two. The Township hereby certifies that it has adopted a capital budget
or a temporary capital budget, as applicable. The capital or temporary capital budget of
the Township is hereby amended to conform with the provisions of this ordinance to the

extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Three. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
