## ORD.#4-2022

## AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING ORDINANCE #2-2022 TO CORRECT VEHICLE WEIGHTS IN THE TOWNSHIP'S TOWING ORDINANCE

**WHEREAS**, on January 25, 2022, the Township Council of the Township of Mount Olive adopted Ordinance #2-2022, which amended Chapter 367, Towing, of the Township Code to update certain provisions; and

WHEREAS, after adoption, two typographical errors were discovered regarding truck weights; and

**WHEREAS**, the Township Council now desires to amend Ordinance #2-2022 to make those corrections.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, in the County of Morris and State of New Jersey as follows:

**SECTION 1.** Ordinance #2-2022 is hereby amended as follows:

- 1. Replace "26,000lb GVWR" in paragraph C of § 367-10 Rates, with "16,000lb GVWR".
- 2. Replace "26,001lb GVWR" in paragraph D of § 367-10 Rates, with "16,001lb GVWR".

**SECTION 2.** All Ordinances of the Township of Mount Olive that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4**. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
