



ORDINANCE AMENDING SECTIONS 3(c)(i) AND 3(c)(iv)  
OF BOND ORDINANCE #4-2020, AS AMENDED BY  
ORDINANCE #9-2020 AND ORDINANCE #15-2021, OF  
THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF  
MORRIS, NEW JERSEY, FINALLY ADOPTED MARCH 3,  
2020, AS AMENDED MARCH 31, 2020 AND JUNE 29,  
2021, IN ORDER TO INCLUDE AN ADDITIONAL  
PROJECT.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF  
MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds  
of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(c)(i) of Bond Ordinance #4-2020, as amended by  
Ordinance #9-2020 and Ordinance #15-2021 (collectively, the "Original Bond  
Ordinance"), of the Township of Mount Olive, in the County of Morris, New Jersey (the  
"Township"), finally adopted March 3, 2020, as amended March 31, 2020 and June 29,  
2021, is hereby amended to include Turkey Brook park improvements and to read as  
follows:

"(c)(i) SDL upgrades, the acquisition of a dais for the Township Council, the  
acquisition of document scanning equipment and Turkey Brook park  
improvements, including all work and materials necessary therefor and  
incidental thereto and further including all related costs and expenditures  
incidental thereto."


Section Two. The description in Section 3(c)(iv) of the Original Bond Ordinance  
is hereby amended to include Turkey Brook park improvements and to read as follows:

"(c)(iv) Baptist Church Phase IIIB interior restoration, the Charles Court Subdivision acquisition, the restoration of the Seward House, Continental Road Phase 1 Resurfacing and Turkey Brook park improvements, including all work and materials necessary therefor and incidental thereto."

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
