ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING SECTION 375-18, VEHICLES OVER CERTAIN WEIGHTS EXCLUDED, OF THE TOWNSHIP CODE TO ESTABLISH A UNIFORM VEHICLE WEIGHT LIMIT ON THE RESIDENTIAL SECTION OF GOLDMINE ROAD, CONNELLY AVENUE, CRESTWOOD CIRCLE, ROLLING HILLS DRIVE, TALL OAKS LANE AND TANGLEWOOD WAY

WHEREAS, there currently exists a need to establish a uniform vehicle weight limit on the entire residential section of Goldmine Road, Connelly Avenue, Crestwood Circle, Rolling Hills Drive, Tall Oaks Lane and Tanglewood Way due to frequent commercial traffic that the roadway cannot support; and

WHEREAS, the Township Chief of Police has reviewed and approved such a limit; and

WHEREAS, the Mayor and Council of the Township of Mount Olive have determined that it is in the best interest of the Township to make this change.

BE IT ORDAINED by the Council of the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Part II, General Legislation, Chapter 375, Vehicles and Traffic, Article II, Traffic Regulations, § 375-18, Vehicles over certain weights excluded, "Gold Mine Road," of the Code of the Township of Mount Olive is hereby amended to read as follows:

SECTION 2. If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

SECTION 3. This Ordinance may be renumbered for purposes of codification.

SECTION 4. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
