**ORDINANCE AMENDING SECTION 3(i)(ii) OF BOND
ORDINANCE #6-2019 OF THE TOWNSHIP OF MOUNT
OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY,
FINALLY ADOPTED MARCH 5, 2019, IN ORDER TO ADD AN
ADDITIONAL PROJECT.**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(i)(ii) of Bond Ordinance #6-2019 of the Township of Mount Olive, in the County of Morris, New Jersey (the “Township”), finally adopted March 5, 2019 (“Bond Ordinance #6-2019”), is hereby amended to include the installation of guard rails at Turkey Brook Park as follows:

“i) Department of Public Works:

(ii) Acquisition and installation of a traffic light at the intersection of Smith Road and Sandshore Road, the acquisition of storage sheds and inventory, road resurfacing and improvements, as more fully described on a list on file in the Office of the Clerk, which list is hereby incorporated by reference as if set forth at length, which includes the Old Flanders Sewer Project, curbing and sidewalk repairs, drainage improvements, as more fully described on a list on file in the Office of the Clerk, which list is hereby incorporated by reference as if set forth at length, and the installation of guard rails at Turkey Brook Park, including all work and materials necessary therefor and incidental thereto.”


Section Two. All other details of Bond Ordinance #6-2019 remain as originally adopted.

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital

or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
