## ORDINANCE # 12 - 2017

AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING § 375-18, VEHICLES OVER CERTAIN WEIGHTS EXCLUDED, OF THE TOWNSHIP CODE TO ESTABLISH A UNIFORM VEHICLE WEIGHT LIMIT ON DRAKESTOWN ROAD

WHEREAS, there exists a need to establish a uniform vehicle weight limit on Drakestown Road due to frequent tractor-trailer traffic that the road cannot support; and

WHEREAS, the Township Chief of Police has reviewed and approved such a limit; and

**WHEREAS**, the Mayor and Council of the Township of Mount Olive have determined that it is in the best interest of the Township to make this change.

**BE IT ORDAINED** by the Council of the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

**SECTION 1.** Part II, General Legislation, Chapter 375, Vehicles and Traffic, Article II, Traffic Regulations, § 375-18, Vehicles over certain weights excluded, of the Code of the Township of Mount Olive is hereby amended to read as follows:

## § 375-18. Vehicles over certain weights excluded.

Vehicles in excess of the gross vehicle weight (GVW) are hereby excluded from the following streets or parts of streets, except for the pickup and delivery of materials on such streets.

**SECTION 2.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 3.** This Ordinance may be renumbered for purposes of codification.

**SECTION 4.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
