





BOND ORDINANCE AMENDING IN ITS ENTIRETY SECTION 3(a)  
OF BOND ORDINANCES NUMBERED 10-2015 AND 4-2016 OF  
THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF  
MORRIS, NEW JERSEY, FINALLY ADOPTED MARCH 17, 2015  
AND MARCH 8, 2016, IN ORDER TO AMEND THE DESCRIPTION  
OF THE PROJECT OF EACH ORDINANCE TO INCLUDE SUTTON  
TANK PAINTING AND IMPROVEMENTS

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF  
MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of  
all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(a) of Bond Ordinance numbered 10-2015 of the Township of  
Mount Olive, in the County of Morris, New Jersey (the "Township"), finally adopted March 17,  
2015, is hereby amended in its entirety to include Sutton Tank painting and improvements to  
read as follows:

"a) Painting of Oakwood Tanks and Sutton Tank painting and improvements, including all work and materials necessary therefor and incidental thereto.	\$700,000	\$665,000	15 years"

Section Two. Section 3(a) of Bond Ordinance numbered 4-2016 of the Township, finally  
adopted March 8, 2016, is hereby amended in its entirety to include Sutton Tank painting and  
improvements to read as follows:


"a) Painting of Oakwood Tanks and Sutton Tank painting and improvements, including all	\$1,200,000	\$1,140,000	15 years"

therefor and incidental thereto.

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
