AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE AMMENDING CHAPTER 375, SECTION 13 PROVIDING FOR THE INSTALLATION OF A STOP SIGN AT THE INTERSECTION OF WASHINGTON STREET AND CARSON ROAD

WHEREAS, the Mount Olive Township Police Department received a request for a traffic study at the intersection of Washington Street and Carson Road, and the police department recommends the installation of a stop sign on Washington Street at the intersection of Carson Road for the safety of the Township's residents; and

WHEREAS, the police department has investigated the traffic circumstances on the roadway in question and it appears that it is in the best interests of public safety, will assist with the controlled flow of traffic with the installation; and a stop sign will conform to the standards of the Manual on Uniform Traffic Control Devices for Streets and Highways; and

WHEREAS, the section of the roadway in question is wholly contained in the Township of Mount Olive; and

WHEREAS, N.J.S.A. 39:4-197 authorizes the Township to pass, without the approval of the New Jersey Commissioner of Transportation, an ordinance regulating the passage or stopping of traffic at congested street corners or other designated points that are under the jurisdiction of the Township;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mount Olive, in the County of Morris, State of New Jersey as follows: Chapter 375 of the Mount Olive Township Code entitled, "Vehicles and Traffic" is hereby amended to incorporate the following (the underscoring represents new language),

SECTION 1. Commencing April 1, 2016, a stop sign shall be installed on Washington Street at the intersection with Carson Road.

SECTION 2. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

SECTION 3. This ordinance shall be incorporated into Chapter 375-13, "Stop Intersections" for purposes of codification.
