ORDINANCE APPROPRIATING \$175,150, \$140,000 OF WHICH IS FROM A GRANT FROM THE COUNTY OF MORRIS AND \$35,150 OF WHICH IS FROM THE OPEN SPACE TRUST FUND FOR THE FORMER BAPTIST CHURCH PHASE IIIB PROJECT IN AND BY THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY AS FOLLOWS:

Section 1. \$175,150 is hereby appropriated, \$140,000 of which is being funded by a grant from the County of Morris Open Space, Recreation, Farmland and Historic Preservation Trust and \$35,150 of which is being funded from the Open Space Trust Fund, for the Former Baptist Church Phase IIIB Project, in and by the Township of Mount Olive, in the County of Morris, New Jersey (the "Township"), including all work and materials necessary therefor and incidental thereto.

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.
