**Mayor Greenbaum:** Yes, I'll start. Very briefly. I've asked Andrew to actually place an ad in the . . . what is it? In the League of Municipalities board or . . .

Mr. Tatarenko: Job listing.

**Mayor Greenbaum:** . . . the job listing to replace Lisa's position now that she's no longer with the Township. So, we will be looking to hire someone in that position. Moving forward, I've asked Andrew to do a first review

of any of the resumes that come in and to call any possible candidates and then I'm going to meet with whoever Andrew thinks is worthy of further discussion . . . discussion about the position. Secondly, on a sadder note, we are going to need to replace the Judge in Town, unfortunately and I've had many different phone calls from individuals who are interested in the job. I have a very short list. Everyone on my list is currently a municipal court judge and in the general vicinity of Mount Olive Township currently, in terms of their current court assignments and so, save one, . . .

Mrs. Labow: Did he retire, Rob?

**Mayor Greenbaum:** He is going to be retiring.

Mrs. Labow: I didn't know.

**Mayor Greenbaum:** And so, that will be an Advice and Consent Appointment once I decide who I think is appropriate for the position.

**Mr. Tatarenko:** Thank you, Mayor. I do have a handful of items. In last year's Budget, we put in for a new street sweeper. I'm happy to announce that, that finally got delivered last week. So, our employees will be . . .

Mrs. Labow: Yay.

Mr. Tatarenko: . . . trained. And I know something that we discussed was to have a more formalized street sweeping schedule, so now that I know we have two street sweepers that work, we can put something together that's, you know, more reliable and to let the residents know. So, I'll be working on that once that sweeper is out on the street. We also filed with the DEP for a preapplication meeting on the Valley Brook Park Project. Our environmental consultant was working on a report to figure out all the constraints. So, we'll be meeting with them in the near future to see if our plan is feasible. If you drove through the parking lot today, you saw that the EV charging station project is also under construction. One of the stations has already been installed at Flanders Park. I saw two go in at Turkey Brook today. They'll be doing Town Hall and then moving on to the Library. So, that should be done by the end of February. We're also moving forward with Phase II of the Clover Hill Tree and Sidewalk Project. We had some leftover funds. We've already identified 39 new trees that need to come down. So, we'll be moving forward on that phase. In the past, we've also had discussions about a Covid-19 After Action Report. The Health Department informed me that there are grants available and consultants who do that report for the municipalities. So, we're looking into that option to finally have some type of a report that we could work off of moving forward and I know Councilman Roman, you had thanked me for doing the CDL agreements, but the credit goes to the DPW. They're the ones who had an employee train to become a trainer. They put a program in place and I just sold it, so . . . that's all that I have.

# LEGAL MATTERS

Mrs. Sharpe: Yes, thank you, Council President. As I alluded to previously, I just wanted to update Council on Daniel's Law, which you may or may not be familiar with. You might recall that a number of years ago, a Federal Judge's son was very tragically shot and killed by someone who came to the Judge's home and as a result of that, the New Jersey Legislature and the Governor enacted what's called Daniel's Law and what that does is require public entities to redact the home address of active and retired judges, prosecutors, law enforcement officers, and their family members if they live in the same household. And what they have to do is they have to go through an Office of Information Privacy that was established within DCA. They have to formally apply to become what's called a covered person and once the DCA approves them, they are . . . the application is sent into a sort of a portal that most often the Clerk's Office, but possibly Department Heads, have to go into. They're notified who is authorized as a covered person. They have to go into electronic and written records that the Township has and redact that information. Realistically, it's probably not going to end up affecting a lot of people but it is going to be an enormous amount of work for the Township to make this happen and unfortunately, the State has been less than helpful in communicating with municipalities on the logistics and the practical application. We know what the law is. The law is pretty simple, but DCA really hasn't done a good job explaining how towns are going to make this happen and there's, you know, the law has a great . . . there's a good reason for it but unfortunately, the implementation has been a bit of a struggle as I

think Michelle will attest to. There's all sorts of implications like if a township has a link on its website where people can go in and pay their utility bills, for example, I believe currently you can look somebody up by name and their address will pop up. We have to make sure that can no longer happen. We have to make sure with OPRA that when there are public records requests, that we are not releasing documents that have addresses belonging to those people. Departments like the Construction Department that may have, you know, files of documents related to a particular block and lot, if that person is subject to Daniel's Law, those addresses are all going to have to be wiped out so that someone might walk into the Construction Department and say "I want to see these records." . . . make sure that they're not able to see that information. So, we're working through with the Clerk's office as we come up with things and, you know, unexpected sort of consequences. Figuring out how to do it, providing legal guidance, making sure that the Township is protected as best we can.

Mr. Roman: Wow.

**Mrs. Sharpe:** Hopefully we'll have more guidance coming from DCA eventually, but it is a, you know, a lot of work. So, I just wanted to give you an update on that.

President Nicastro: Colleen.

Mrs. Labow: Thank you. Sue, for real estate, I have a link that I go to the New Jersey State Tax Record.

Mrs. Sharpe: Mhm.

Mrs. Labow: Anybody can log in. So, are they going to go through and change all of those as well?

**Mrs. Sharpe:** Yeah, the County and the State's going to have to address what they control. We have to address what we control. We have to make sure there aren't links. You know, there's third party vendors that handle a lot of this, so, we don't quite know what's going to happen with that information but we just have to ensure our responsibility is controlling what we have and there are penalties . . .

Mrs. Labow: Mhm.

**Mrs. Sharpe:** . . . for, you know, accidentally releasing the information.

Mr. Roman: Wow.

**Mrs. Sharpe:** So, we have to be very, very careful with that but yeah, I think . . . I think, you know, it wasn't thought through in terms of nobody really thought into the future and all these little pieces.

Mrs. Labow: Yeah, there's a lot of stuff you need to get information on, but the other thing too is I understand with like a judge and all those other people, you want to protect your family but there's a lot of times when there's some really hot and heavy disagreements going on, even here on the local level. What's to prevent somebody from showing up at my house and shooting my, you know, kids. I mean it's . . . I don't know, it just seems . . . I'm waiting for somebody to sue them and say it's discrimination. What about the rest of us? You know.

**President Nicastro:** Yup.

Mrs. Labow: That's just my thought.

President Nicastro: We'll see.

**Mr. Roman:** Sue, is it . . . so is it incumbent on the Township to be proactive and find those individuals or a person that qualifies under the Daniel's Law has to reach out to the Township and say, "Hey, by the way, I

live in your Township."?

Mrs. Sharpe: No, there's no interaction between covered individuals and the Township. It has to go through DCA and in fact, one thing DCA has made very clear is that if an individual reaches out to say Michelle, and says, "Hey, I'm one of these covered people. I need you to make sure my information is redacted." They need to be directed back to DCA to go through that official vetting process. So, ultimately, they have to be approved by DCA. Michelle and possibly department heads who are registered, they're called redactors, will go to their portals, they get a notification, and only then is that person basically redacted.

**Mr. Roman:** And it sounds like there's a lot of work involved in doing that. Will there be funds provided by the State in order to do the redaction?

Mrs. Sharpe: Of course not.

Mrs. Labow: No, I was going to say . . .

**President Nicastro:** Do they ever?

Mrs. Labow: ... I don't think so.

**Mr. Ferrante:** That's the only question.

**Miss Masser:** Right now, just to update everybody; I have four people who already registered and before the meeting I had gotten another notification. So, I have to go in. I will go in tomorrow and see what the new notification is and I have 30 days to, as the redactor, attest that I have redacted all the records in Mount Olive Township.

Mrs. Labow: Oh, wow.

**Mrs. Sharpe:** And I think the plan is to have, you know, other people, maybe department heads, designated as redactors. They'll be in charge of redacting their own records but then everybody will . . . it will all come back to Michelle, so you have sort of a central point of contact overseeing everything and we all know when . . .

Miss Masser: Like OPRA.

**Mrs. Sharpe:** We know what a great job Michelle does and how organized she is and, you know, I feel very confident, it being under her control.

**Mrs. Labow:** I just . . . I have another question though.

**President Nicastro:** What's that?

**Mrs. Labow:** I have a question about that. So, say if somebody who qualified is . . . you know, you have to put in for that and redact everything. So, let's say they did a project and there was a bunch of things in construction and so, you have to go in and redact all their information, so we don't ever actually have the information to go back to at any point?

Miss Masser: No.

**Mrs. Sharpe:** You'd have to like tag . . . you'd redact the information, but you'd maybe tag the file physically to say this is the address for your own . . .

Mrs. Labow: For our . . .

Mrs. Sharpe: Because you have to be able to function.

Mrs. Labow: Right, you have to be able . . .

Mrs. Sharpe: Yes.

Mrs. Labow: . . . to clear that stuff. Like if somebody . . .

Mrs. Sharpe: Right. Yeah.

Miss Masser: Internally, they're going to . . .

President Nicastro: Know.

Miss Masser: . . . know, you know, it needs to be fine-tuned. It's just like OPRA. When OPRA . . .

Mrs. Labow: Right.

**Miss Masser:** . . . came, there was a lot of questions. There was a lot of things. How is this going to affect the election process? Looking up the people.

Mrs. Labow: Right.

Miss Masser: You know, municipal records, deeds . . .

Mrs. Labow: Mhm.

Miss Masser: . . . things of that nature, so, it's going to have to be fine-tuned. It's going to take . . .

Mrs. Labow: Right.

**Miss Masser:** . . . some time but they're kind of just like throwing this at the Township's lap saying, "This is what you have to do now."

Mrs. Labow: Mhm.

Miss Masser: Like Sue said, there is no guidance.

Mrs. Labow: Right. Yeah.

**Miss Masser:** We were on a webinar, you know, on the webinar there wasn't really that much guidance. Go read Daniel's Law is what they told us and . . .

President Nicastro: Figure it out.

**Miss Masser:** . . . and talk to your attorney.

Mrs. Sharpe: Talk to your attorney.

President Nicastro: Yeah . . .

Mr. Stewart: Wow.

Miss Masser: You know, that's kind of like what we always get.

**Mrs. Labow:** Yeah, because I'm thinking like in terms of real estate. We always recommend that our clients get OPRA requests and find out any work . . .

President Nicastro: Right.

Mrs. Labow: . . . that's been done on a house and . . .

President Nicastro: You still can do that.

Mrs. Labow: . . . the mortgage company wants to know . . . oh, it has a new roof . . .

Mrs. Sharpe: For the . . . yeah.

President Nicastro: You're still going to do it; you just won't know the name.

Miss Masser: We're now going to cross reference . . .

Mrs. Labow: Yeah.

**Miss Masser:** . . . now, when an OPRA comes in, I have to cross reference and make sure that, that particular person is not on my thing.

**President Nicastro:** That's got to be confusing for real estate.

Miss Masser: An example would be, I had an OPRA request for tax liens. Pages and pages. Well, I went in and I went through . . . normally, I would send it out to the person, the requestor, but now I have to stop and I have to . . . after I redact, it has to be off of that. Now I have to go through and make sure that in that list she gave me, that there were no addresses on there pertaining to the person who registered, and as my list grows, you know . . .

Mrs. Sharpe: It's a whole other layer.

Mrs. Labow: Yeah.

Mr. Stewart: Wow.

Miss Masser: So, we're going to have to fine-tune how we're going to that.

President Nicastro: I'm sure.

Mrs. Labow: We're going to have to hire another person for your office.

President Nicastro: No.

Miss Masser: I already need one of those.

Mrs. Labow: I know. You already need that. Well, this will secure it.

**Mrs. Sharpe:** That's why when, you know, another issue is people give their names and addresses and those are in the Minutes.

President Nicastro: Yeah.

**Mrs. Sharpe:** Now, we don't know in the past who might have come spoken. We may need to send letters to people who are on this list and say, "Hey, have you spoken at a public meeting?", so we can go back in those Minutes but, we suggested that going forward, when Joe says, you know, "Please state your name and address.", we need to say, "Unless you are a covered person . . . you're registered as a covered person."

Mrs. Labow: Yeah.

Mrs. Sharpe: Under Daniel's Law. Put the public on notice.

**Mrs. Labow:** They have to absolutely be already registered, right?

Mrs. Sharpe: Yes.

**Mrs. Labow:** They just can't qualify and not . . .

Mrs. Sharpe: Yes.

**Mrs. Labow:** . . . have registered.

**Miss Masser:** They have to be registered. I would've already been notified.

Mrs. Sharpe: Yeah.

**Miss Masser:** As soon as they register, it funnels down. The State, the County, and the local municipality, you know, I only get what's in Mount Olive. So, someone who . . . say one of our officers that works here registers, but he lives in another town; I'm not going to know he registered. Only that town is going to know.

**Mr. Roman:** When people talk and speak and we ask for name and address, are they allowed to just say "So and so, Budd Lake, New Jersey"? Are they allowed to say that?

**January 24, 2023** 

**Mrs. Sharpe:** Well, we looked at that. We really . . . you know, it's important for towns to know who is speaking.

Mr. Roman: Mhm.

**Mrs. Sharpe:** And it's a valid request but, you know, but putting them on notice and saying "Unless you're Registered.", then, you know, it's on them to not provide their address under that.

**Mr. Roman:** So, does . . . every time a resident comes up to speak, do we have to follow it up name and address unless you're on Daniel's Law or is that something that the . . .

Miss Masser: I think during the public portion.

Mrs. Sharpe: Yeah, we've recommended that Joe just says that.

**President Nicastro:** Yeah, we just say "Unless you're registered."

Mr. Roman: Okay.

Mrs. Sharpe: If they're registered and they give their address anyway, that's really on them.

Mr. Roman: All right. That's all I have.

**President Nicastro:** Okay. Thank you, very much. Always challenging. The State is great. All right, Council Reports, Mr. Aaron. Board of Education.

Mrs. Labow: I gave the Open Space last time and the Senior.

President Nicastro: Yup.

Mrs. Labow: And for the Board of Health, I already spoke about that a little while ago. We had our Reorganization meeting last week. It was very good and we are . . . we were still doing Zoom meetings and Trevor said he thinks that we're all supposed to go to in person meetings, however, when I was talking to a couple people, we're going to check and see if we can remain with Zoom because it's like for instance, our doctor, Dr. Miccio, he's . . . when we had live meetings, he was like . . . would finally get here like a few minutes before because he had patients and now, he gets done with a patient, goes in his office and he's with us and

Mrs. Labow: He's actually one of the ones that told me he would prefer to stay Zoom . . .

Mrs. Labow: You know, so, and like our health officer lives quite a distance away, so he kind of like . . .

Mrs. Labow: Okay. Yeah, because like for our meetings, for the most part, they're about 15 minutes.

President Nicastro: I know.

Mrs. Sharpe: Mhm.

Mrs. Labow: You know, it seems like a waste of time and gas. It takes more time . . .

Mrs. Sharpe: Right.

**Mrs. Labow:** Even for me and I live right in Town, to actually . . . so I wanted to just investigate that because it is . . . I think it's more time efficient and financially.

Mrs. Sharpe: I can take a look at that for you as well.

Not all Recreation Committee Members were able to participate but we did have testimony provided by John Geiger, Derrick from the Health Department, and we were also able to question Mrs. Hars.
